According to article 69 of the basic law: "the institutions of civil society, including the church, associations and other non-profit organizations, local government authorities, the media and civil society is the basis. The activities of civil society is carried out in accordance with the law".

According to this constitutional article now: "the republic of uzbekistan in trade unions, political parties, scientists and society, women's organizations, veterans, youth and persons with disabilities, organizations, creative associations, mass movements of citizens and public associations, other associations recognized. Dissolving the public associations, their activities, or just put a limit to ban is carried out on the basis of the decision of the court".

At the same time, officials of state bodies and non-profit should not interfere in the activities of the organization and, hence, state bodies and civil society institutions working independently from each other to guarantee that has put off many.

According to the second paragraph of article 72 of the new home edition of the encyclopedia: "officials of state bodies and non-profit to interfere in the activities of the organization, as well as non-profit organizations to interfere in the activities of state bodies and officials does not allow".

In addition, the issue of the basic law in support of civil society institutions in the range of powers of the cabinet of ministers took place. Article the sixth paragraph of article 115 of the constitution, according to the cabinet of ministers: "the implementation of measures to support civil society institute, socio-economic and social development will ensure their participation in the development and implementation of partnership program"<sup>2</sup>.

Also it should be noted that, in the tenth paragraph of article 115 of the constitution the powers of the government as one of the basic article: "the work of the executive bodies in openness and transparency, legitimacy and efficiency to ensure the fight against corruption in their activities, see versions of the task set. This, in turn, in the same process also implies that the public would be out of control by the institutions of civil society"<sup>3</sup>.

In particular, the development of civil society in the decision of the prezdent of the republic of uzbekistan was adopted.
